

CO-OP® FIND YOUR SUMMER SWEEPSTAKES 2026

OFFICIAL RULES

The "CO-OP® Find Your Summer Sweepstakes 2026" game (the "Game") is offered by Federated Co-operatives Limited ("Game Sponsor") at the Game Sponsor's participating member retail co-operatives' CO-OP® Food stores, Gas Bars, Home and Building Centres in Ontario, Manitoba, Saskatchewan, Alberta (Excluding all Calgary Co-operative Association Limited ("Calgary Co-op") locations), British Columbia and the Northwest Territories ("Participating Retail Co-op(s)") and is administered by WSP International Limited ("Administrators"). Game Sponsor, Participating Retail Co-ops, and Administrators hereinafter will be referred to as the "Game Entities".

NO PURCHASE NECESSARY TO PLAY.

General Game Information: Customers can earn online entries for sweepstakes prize drawings and instantly win prizes by logging in with an online Co-op account ("Co-op Account") on our contest website and uploading a qualifying cash register receipt or by entering a Bonus Code, as described in Rule 3, below. Any questions, concerns, or comments regarding the Game can be forwarded to support@findyoursummer.crs or by sending a self-addressed, stamped envelope to "Co-op Find Your Summer Sweepstakes, c/o P.O. Box 3009, M.I.P., Markham, ON, L3R 6G4".

1) **GAME DATES:** The Game begins at 12:01 am ET on July 2, 2026 (the "Game Start Date") and is scheduled to end on August 26, 2026, at 11:59 pm PT (the "scheduled Game End Date"). The period between the Game Start Date and the scheduled Game End Date is known as the "Game Period".

2) **WHO CAN PLAY:** The Game is open to all legal residents of Ontario, Manitoba, Saskatchewan, Alberta, British Columbia, and the Northwest Territories who have reached the age of majority in their Province or Territory of residence as of Game Start Date. Employees, operators, and directors of Participating Retail Co-ops ("Team Members"), as well as those persons that reside with any Team Member, are not eligible to play or win prizes. Employees and members of the Board of Directors of the Game Sponsor and Game Sponsor's subsidiaries as well as all General Managers, Chief Executive Officers, and Board of Directors of any of the Participating Retail Co-ops ("Limited Eligibility Players") as well as those persons that reside with any Limited Eligibility Player are not eligible to play or win prizes. Employees of the Administrators or the Game Sponsor's distributors, sales representatives, advertising and promotion agencies, and agents, participating prize sponsors, or any entity that the Game Sponsor contracts with, specific to this contest, as well as those persons that reside with such employees, are not eligible to play or win prizes.

3) **HOW TO PLAY:** Go to www.findyoursummer.crs (or follow the link to Find Your Summer Sweepstakes in the Co-op mobile app available in the [Apple App Store](#) and [Google Play store](#), or follow the link to Find Your Summer Sweepstakes at www.co-op.crs) at any time throughout the Game Period and follow the instructions to sign in with your Co-op Account. If you do not have a Co-op Account, you can sign up for free by following the instructions on screen, or by visiting www.co-op.crs. Once signed in, follow the instructions to upload a photo of a qualifying cash register receipt or enter a Bonus Code.

A. **Upload a Receipt:** To qualify, a cash register receipt must be from a Participating Retail Co-op, be from a transaction during the Game Period, and be for a minimum spend of \$50.00 after tax. Purchases of pharmacy prescription items, postage, bus passes, gift cards, event tickets, passes and lottery tickets, alcoholic beverages, cigarettes, tobacco products, vaping products, firearms, ammunition, money orders or money transfers and any other items that are legally prohibited by the Province or Territory where the transaction occurs do not contribute to the minimum spend and are ineligible to win any prize. Hereinafter, qualifying cash register receipts that meet these criteria will be referred to as Qualifying Receipts ("Qualifying Receipt(s)"). With every Qualifying Receipt uploaded, you will:

- i. **Receive a chance to win an instant win prize ("Instant Prize"):** With every Qualifying Receipt Uploaded, you earn a game play ("Game Play") and may receive a message that you've won an Instant Prize. See Table 1 below for a list of all available Instant Prizes, values, eligible receipt types and odds to receive. See **"WHAT TO DO WHEN YOU REVEAL AN INSTANT WIN PRIZE"** below for details on how to redeem.
- ii. **Receive sweepstakes entries ("Entries"):** For a Qualifying Receipt with a total eligible amount of \$50.00 to \$99.99, you will receive one (1) Entry. For a Qualifying Receipt with a total eligible amount of \$100.00 to \$149.99, you will receive two (2) Entries. For a Qualifying Receipt with a total eligible amount of \$150.00 to \$199.99, you will receive three (3) Entries. For a Qualifying Receipt with a total eligible amount of \$200.00 to \$249.99, you will receive four (4) Entries. For a Qualifying Receipt with a total eligible amount of \$250.00 or

more, you will receive five (5) Entries. You will also earn bonus Entries (“Bonus Entry/Entries”) when your Qualifying Receipt includes a featured participating product (“Participating Product(s)”). Participating Products will be featured in-store and in flyers (See store or www.co-op.crs/flyers for details). You will receive one (1) additional Bonus Entry per Participating Product purchased. There is a maximum of one (1) Bonus Entry per Participating Product, regardless of the quantity of that product purchased. Maximum five (5) Bonus Entries per Qualifying Receipt.

With each Entry you receive, you may choose which sweepstakes prize drawing you would like to assign it to. Each successfully assigned Entry counts as one (1) entry for a chance to win the selected prize drawing. The odds of winning any sweepstakes prize depend on the number of eligible Entries assigned to that prize drawing in accordance with these Official Rules before the applicable drawing date. See Table 2 below for the available sweepstakes prizes and their corresponding drawing dates.

There is a total maximum of ten (10) Entries per Qualifying Receipt. There is a maximum of five (5) receipt uploads per day of the Game Period. There is a maximum of two thousand eight hundred (2,800) Entries (earned from Receipt Uploads) per person throughout the Game Period.

No Purchase Entry: You may obtain one (1) Game Play for a chance to win an Instant Prize and receive ten (10) Entries without making a purchase by mailing your Name, Address, Province, Postal Code, Telephone Number, and Email Address, clearly printed or typed on a 3 x 5 inch card or piece of paper, to: **"Co-op Find Your Summer Sweepstakes NO PURCHASE REQUEST, c/o P.O. Box 3009, M.I.P., Markham, ON, L3R 6G4."** No Purchase Requests must be received on or before August 26, 2026. Limit five (5) No Purchase Request per person per day during the Game Period. There is a maximum of two thousand eight hundred (2,800) Entries (earned from No Purchase requests) per person throughout the Game Period. Mechanically reproduced or computer-generated requests are not permitted. Eligible participants will receive an email at the email address provided containing instructions to claim their play and entries.

B. Enter a Bonus Code: Look for Bonus Codes that the Game Sponsor posts on its social media channels and/or other advertising or promotional materials and follow the instructions to enter each Bonus Code. For each valid Bonus Code entered, you will receive Bonus Entries. With each Bonus Entry you receive, you may choose which sweepstakes prize drawing you would like to assign it to. Each successfully assigned Bonus Entry counts as one (1) entry for a chance to win the selected prize drawing. The odds of winning any sweepstakes prize depend on the number of eligible Entries assigned to that prize drawing in accordance with these Official Rules before the applicable drawing date. See Table 2 below for the available sweepstakes prizes and their corresponding drawing dates. Each Bonus Code may be entered only once per person. This Game is in no way sponsored, endorsed, administered by, or associated with Facebook, Instagram, or X.

4) PRIZES:

A. Instant Prizes: There are 42,836 Instant Win Prizes available to be won from a total of 144,000 available Game Plays, as outlined in Table 1 below. WHAT TO DO WHEN YOU REVEAL AN INSTANT PRIZE MESSAGE: For Food and Gas Bar Receipt Prizes: Follow the instructions to visit the **My Game History** page and select "**Redeem Now**" to activate your prize coupon during your next visit to your selected Participating Store, any time before the close of business on September 2, 2026. Activate your prize coupon on your mobile device and have it available at the Participating Store. Select the product identified on your prize coupon and take it to the checkout to claim your prize. You must present your winning prize coupon at checkout. The cashier must scan the barcode on your prize coupon or manually enter the PLU code. Once activated, your prize coupon is valid for five (5) minutes and will automatically void if not redeemed within that time. To claim your prize, you must correctly answer, without assistance, a mathematical skill-testing question administered by the cashier. Instant Win Prizes do not include applicable taxes, environmental or recycling fees, or bottle deposits, where applicable. No cash value or cash back. Upon receipt of the prize, the Participating Co-op Home and Building Centre will contact you by telephone and/or mail to make arrangements for you to pick the prize. A minimum of three (3) attempts will be made to contact the winner to arrange for pick-up of the prize. Prizes that are not claimed within thirty (30) days of the third attempt to be contacted will be deemed forfeited. No prize substitutions are allowed, except as provided herein. Game Sponsor reserves the right, at its sole discretion, to substitute an advertised prize (or portion thereof) with a prize of equal or greater value for reasons that may include but are not limited to unavailability; or production delays caused by labour disruptions, adverse weather conditions or other unforeseen events.

If a potential winner refuses or fails to timely return the required documents, in accordance with these Official Rules, or is found to have violated the Official Rules of the Game in any way, or is deemed ineligible to receive a prize for any reason, or if any prize or prize notification from Game Sponsor or Administrator is returned as undeliverable, the potential winner will be disqualified and will be deemed to have forfeited the prize in question. Allow approximately four (4) to eight (8) weeks for shipment of prizes to Participating Retail Co-op following verification. Distribution of prizes will be done in a timely manner without undue delay. Upon receipt of the prize, the Participating Retail Co-op will contact you by telephone and/or mail to make arrangements for you to pick up the prize at the Participating Retail Co-op. A minimum of three (3) attempts will be made to contact the winner to arrange for pick-up of the prize. **Prizes that are not claimed within thirty (30) days of the third attempt to be contacted will be deemed forfeited.**

No prize substitutions are allowed, except as provided herein. Game Sponsor reserves the right, at its sole discretion, to substitute an advertised prize (or portion thereof) with a prize of equal or greater value for reasons that may include but are not limited to unavailability; or production delays caused by labour disruptions, adverse weather conditions or other unforeseen events.

6) ODDS CHART: Odds of winning any Sweepstakes Prizes depend on the number of qualified Entries assigned and eligible for each drawing, received prior to each drawing, as described herein. Odds of receiving any Instant Prize are outlined in Table 1, above.

7) PRIVACY: The Game Sponsor will be collecting personal data about you for the Game and for purposes of the game to validate winning entries. By entering the Game, you consent to the collection of personal data, and you grant the Game Sponsor permission to send a winner notification to you.

No such personal data will be transferred or sold to any third party except in the following circumstances:

- B) When in good faith we believe the law requires it;
- C) Under limited circumstances specifically described to you when we collect the information, such as in the rules of games, sweepstakes, or other promotions;
- D) To our respective agents for data processing purposes, our respective professional advisors, and promotional and marketing agencies, provided that such agents, professional advisors, and promotional and marketing agencies are restricted from using the information for any purpose other than as described in these Official Rules.
- E) To Game Sponsor's agents for data processing purposes, or to its professional advisors and promotional and marketing agencies, provided that such agents, professional advisors, and promotional and marketing agencies are restricted from using the information for any purpose other than as described in these Official Rules.

Game Sponsor may match aggregated, statistical user information to parameters established by third parties, without releasing any personally identifiable information. Game Sponsor may share aggregate information with trading partners, co-branded locations, participating sponsors, and advertisers; however, this aggregated information will not contain personally identifiable information. Any requests for access to the information that entrants have supplied, or to update or rectify such

information, must be made in writing by sending a self-addressed envelope with your request to: "Co-op Find Your Summer Sweepstakes, c/o P.O. Box 3009, M.I.P., Markham, ON, L3R 6G4".

Federated Co-operatives Limited (FCL) respects your right to privacy and will use your personal information only to conduct the Contest and for the purpose as described in the Official Rules. Information collected is used solely to administer the Contest and is not sold, rented, or loaned to any third parties. No correspondence will be entered into except with selected entrants (unless you have opted in to receive future offers and communications from CO-OP). FCL will manage the entrant's personal information in accordance with its privacy policies and practices, which can be accessed by contacting the FCL privacy officer at privacy@fcl.crs; and in accordance with applicable laws. By completing and submitting a contest entry form you consent to the collection, use, and disclosure of your personal information for the purposes stated herein.

8) **PUBLICITY:** Acceptance or Submission of a Prize or Prize claim (see Rule 4 and 5 above) constitutes permission for the Game Entities to use your name, voice, picture, or other likeness for advertising, marketing, public relations, or other promotional purposes worldwide in commerce and in any media without limitation or further compensation.
